## Regional Catastrophic Preparedness Grant Program (RCPGP) Updates

*Life Sustaining Commodity Distribution Planning:* The Bay Area UASI developed 104 local C-POD site activation plans, an online map/GIS data layer of the Bay Area UASI region's potential C-POD sites, a summary of anticipated resource needs for operating these C-POD sites, and templates/guidance for continued commodity distribution planning. Site specific plans and locations are designated as For Official Use Only, but the complete toolkit may be accessed by visiting [bayareauasi.org/cpod](http://bayareauasi.org/cpod). This includes downloadable, customizable planning templates and exercise materials. Additional tools include resource estimation calculators, guidance for developing MOUs, and training curriculum for *C-POD Operations and Management (including a condensed video version)* and *Disaster Logistics for Practitioners*.

*Regional Pandemic Preparedness:* This project involved collaboration of Bay Area agencies to review best practices and challenges from the COVID-19 pandemic. Tools including an online, searchable, crisis communication toolkit, a pandemic preparedness framework, and a scare resource decision making tool are available at [bayareauasi.org/PandemicPreparednessPlanning](http://bayareauasi.org/PandemicPreparednessPlanning).

## SF Bay Area Secure the Cities (STC) Grant Program Update

STC protects the Bay Area against threats from unauthorized use of radiological or nuclear (RN) materials by providing detection equipment, training, exercise and programmatic support, and expertise to develop regionally coordinated RN detection capabilities. Bay Area UASI staff attended the STC Senior Executive Meeting in Washington D.C. from July 18 - July 20 to receive threat briefings, collaborate with partner agencies, understand best practices and develop capabilities. Maritime PRND PER-350 were delivered to maritime public safety partners in the region, and the UASI has received STE RadPak Max backpacks to be distributed to Principal Partner agencies. Staff continue to draft modifications to PMO documents based upon Semi-Annual STC meeting information and Tabletop AAR.

## Risk Management Program Updates

The Bay Area UASI has been working on the annual capability assessment requirement, known as the Stakeholder Preparedness Review (SPR), which will be submitted to FEMA in December. Through this process, regional stakeholders describe capability gaps, identify strategies for closing the gaps, and perform quantitative estimates on current capabilities. And in March, the Risk Management Work Group held its first meeting with subject matter experts from the local, regional, state, and federal levels to ensure that the Bay Area's Department of Homeland Security (DHS) relative Risk Score accurately reflects the region's terrorism risk. Staff has also provided feedback to DHS on the various threat, vulnerability, and consequence elements of the DHS Risk Methodology.

## Cybersecurity Program Update

On June 14, 2023, Mikyung Kim-Molina spoke on a panel titled, "Scaling Cyber Defense: State and Local Partnerships" at the Cyber Civil Defense Summit in Washington D.C. The Cyber Civil Defense Summit is hosted by the UC Berkeley Center for Long-Term Cybersecurity (CLTC) and focuses on exploring novel solutions to help local governments, private sector, and community-based organizations defend themselves online. This sold-out event included high-level cyber professionals, academics, government officials, and policymakers who convened to discuss creative and innovative programs designed to bolster local and regional cyber resilience efforts.

## Compliance Corner

The FY24-25 Project Proposal Guidance is posted on the UASI website, and a **Project Proposal Kickoff meeting to apply for FY24-25 UASI funds will be held in Dublin on September 14th at 1pm** to inform applicants on the proposal submission process, timelines, and grant requirements. The **WebGrants application portal will open on Friday, September 15th** for a three-week period to accept proposals.

We have implemented a much-needed upgrade to WebGrants, which has the same functionality but a cleaner look and feel. Potential grant applicants will receive training on WebGrants at the Kickoff meeting. Reminder: if you need to secure sole source approval as part of your procurement process, there is a 45-day turnaround time to get Noncompetitive Procurement Authorization requests approved by the State. Please plan ahead!
