Public Participation:

It is the policy of the Approval Authority to encourage and permit public participation and comment on matters within the Approval Authority's jurisdiction, as follows.

- Public Comment on Agenda Items. The Approval Authority will take public comment on each item on the agenda. The Approval Authority will take public comment on an action item before the Approval Authority takes action on that item. Persons addressing the Approval Authority on an agenda item shall confine their remarks to the particular agenda item. For each agenda item, each member of the public may address the Approval Authority once, for up to three minutes. The Chair may limit the public comment on an agenda item to less than three minutes per speaker, based on the nature of the agenda item, the number of anticipated speakers for that item, and the number and anticipated duration of other agenda items.
- General Public Comment. The Approval Authority shall include general public comment as an agenda item at each meeting of the Approval Authority. During general public comment, each member of the public may address the Approval Authority on matters within the Approval Authority's jurisdiction. Issues discussed during general public comment must not appear elsewhere on the agenda for that meeting. Each member of the public may address the Approval Authority once during general public comment, for up to three minutes. The Chair may limit the total general public comment to 30 minutes and may limit the time allocated to each speaker depending on the number of speakers during general public comment and the number and

- anticipated duration of agenda items.
- *Speaker Identification*. Individuals making public comment may be requested, but not required, to identify themselves and whom they represent.
- Designated Public Comment Area. Members of the public wishing to address the Approval Authority must speak from the public comment area.
- Comment, Not Debate. During public comment, speakers shall address their remarks to the Approval Authority as a whole and not to individual Approval Authority representatives, the General Manager or Management Team members, or the audience. Approval Authority Representatives and other persons are not required to respond to questions from a speaker. Approval Authority Representatives shall not enter into debate or discussion with speakers during public comment, although Approval Authority Representatives may question speakers to obtain clarification. Approval Authority Representatives may ask the General Manager to investigate an issue raised during public comment and later report to the Approval Authority. The lack of a response by the Approval Authority to public comment does not necessarily constitute agreement with or support of comments made during public comment.
- Speaker Conduct. The Approval Authority will not tolerate disruptive conduct by individuals
 making public comment. Speakers who use profanity or engage in yelling, screaming, or other
 disruptive behavior will be directed to cease that conduct and may be asked to leave the meeting
 room.

1. Roll Call

UASI Acting Chair Rich Lucia called the meeting to order at 10:00 AM and General Manager Craig Dziedzic subsequently took the roll. Acting Chair Rich Lucia was present. Members Mary Ellen Carroll, Jeanine Nicholson, Toshia Shavies Marshall, Ray Riordan, Dana Reed, Mike Casten, Gerry Malais, Mark Robbins, and Brendan Kearney were present. Member Bob Doyle was absent, but his alternate Dave Augustus was present.

2. <u>Approval of the Minutes</u>

Acting Chair Lucia asked for any comments or questions concerning the minutes from the August 9, 2018 meeting. Seeing none, he requested a motion to approve the minutes.

3. General Manager's Report

(a) Notification of Subrecipient Award FY18

General Manager Craig Dziedzic confirmed the Bay Area UASI's receipt of the FY18 Homeland Security Grant Program award letter from the California Office of Emergency Services (Cal OES) in the amount of \$22,742,500. The Management Team also received the California Supplement to the Federal Notice of Funding Opportunity for the FY 2018 Homeland Security Grant Program. The Management Team has sent all FY2018 MOUs to all grant subrecipients so they may begin to incur expenses after the execution of the MOU.

(b) UASI FY 2019 Project Proposal Process

The Bay Area UASI has received 159 applications for the FY19 Project Proposal Process amounting to approximately \$31,950,349, which is above the anticipated funding allocation of \$23,442,500. Approval Authority members will have an opportunity to review the proposals November 13, 2018 through November 30, 2018 before the hub regional prioritization meetings begin in January 2019.

(c) Approval of the 2019 Calendar for Approval Authority Meetings

(d) Management Team Update

The application period for the Communications/Technologies Project Manager position has closed and we are currently in the selection process. Also, Assistant General Manager Catherine Spaulding has left the Management Team and accepted a new position with the San Francisco Public Utilities Commission.

(e) Management Team Tracking Tool and Future Agenda Items

There were no additions to the tracking tool.

One member of the public made a comment.

4. Regional Training and Exercise Program Update

General Manager Craig Dziedzic presented an update on the status of the approval process for the FY18 UASI Regional Training and Exercise MOU between the Bay Area UASI and Alameda County. There were two action items: (a) Preclude bifurcation of the Bay Area Training and Exercise Program and (b) Consider a reallocation of the Training and Exercise funds if the Alameda County Board of Supervisors does not approve the MOU by March 2019.

bifurcating the Bay Area UASI Regional Training and Exercise Program and table

5. Preventing Violent Extremism Statewide Program Update

Cal OES Program Coordinator Kyle Trambley presented to the Board updates of the Preventing Violent Extremism Statewide Program. Program services that are now offered include the California Community Portal, "First Steps Training", a 2018 Non-Profit Pilot Grant Program, and PEACE Plans to provide roadmaps for interested communities.

One member of the public made a comment.

6. FY19 UASI Hub Funding Formula

Project Manager Amy Ramirez proposed the Hub Funding Formula for the FY19 grant cycle. The Bay Area UASI uses DHS' Metropolitan Statistical Area risk formula to guide the administration of grant dollars among the four hubs. The FY 2019 allocation percentages will be as follows: East Hub = 23.6%; North Hub = 6.6%; South Hub = 25.1%; West Hub = 44.7%.

7. THIRA/SPR Update

Project Manager Amy Ramirez presented updates to the 2018 Threat and Hazard Identification and Risk Assessment (THIRA) for approval for submission to the Federal Emergency Management Agency (FEMA). This year, FEMA modified the THIRA and added a new requirement, the Stakeholder Preparedness Review (SPR). The purpose of the SPR is to identify a community's capacity to address the threats and hazards identified in the THIRA.

One member of the Board made a comment. Two members of the public made comments.

8. Public Safety Information Sharing Update

Project Manager Mikyung Kim-Molina and NCRIC Assistant Deputy Director Brian Rodrigues presented to the Board updates of public safety information sharing efforts in the Bay Area region. Accomplishments include over 150 participating agencies, 16,000 active users, and 726,000 searches over the past 12 months. Next steps include a LEAP and COPLINK merger, training on the new LEAP and COPLINK platform, and expansion to include more jurisdictions.

One member of the public made a comment.

9. <u>Critical Transportation Capability Building Project</u>

Project Manager Corinne Bartshire presented highlights of the Critical Transportation Capability Building project. The project will begin in January 2019 with the goal of building local government capabilities, partnerships, and coordination. Deliverables will include a regional workshop series, local government plan evaluations and regional improvement strategy, documentation of Bay Area transportation resources, and a local government planning toolkit.

One member of the public made a comment.

10. Regional WebEOC Standardization Project Update

Project Manager Corinne Bartshire and Emergency Services Coordinator Woody Baker-Cohn presented to the Board updates on the progress of the regional WebEOC standardization project. Accomplishments include statewide shelter status reporting, a statewide mission/resource request board, and prototype SitRep reporting. Next steps will be to build and deploy a Bay Area transportation resource request board, finalize the SitRep/Situation Reporting board, and connect all Bay Area WebEOC systems with Cal OES' updated WebEOC.

Two members of the Board made comments.

11. BayRICS JPA Quarterly Report

BayRICS General Manager Corey Reynolds provided a quarterly report of the strategic activities, progress, and future goals of the BayRICS Authority.

12. FY16 UASI Spending Report

Chief Financial Officer Tristan Levardo reported updates on the expenditures of the FY2016 UASI grant. Several projects were approved for extension to complete the work.

13. Announcements – Good of the Order

(a) FY19 UASI Project Proposal Update (Discussion)

The Management Team received a total of 159 project proposals, which were reviewed by our project managers and given the opportunity to correct any compliance issues. From November 14 through December 1, 2018, Approval Authority members were sent these proposals from their respective jurisdictions to review. (b) Management Team Update (Discussion)

Communications and Technologies Regional Project Manager Position

I am pleased to announce the selection of Mikyung Kim-Molina as the UASI Communications and Technologies Regional Project Manager, which involves implementing regional programs/project planning with a focus on cyber security, public information and warning and emergency communications to meet Department of Homeland Security goals.

Mikyung has worked for the City and County of San Francisco for over 26 years. She has worked for the San Francisco Adult Probation Department and Public Health Department. For the past seven years, Mikyung has worked on the UASI Management Team as a Principle Analyst specializing in contract management and supporting the program team in various work group/project management tasks, including the regional cyber security and emergency management initiatives.

Mikyung is a graduate of the University of California at Berkeley with a Bachelor of Arts in Legal Studies and San Francisco State University with a Masters of Public Administration.

Emergency Services Coordinator I Position

Anthony Perez who serves as the UASI Emergency Services Coordinator, supporting the day to day operations of the office, will be leaving for a new promotive opportunity. He will be joining the San Francisco Department of Emergency Management Watch Center. Mr. Perez' last day in the office will be January 25, 2019. We will be backfilling the position.

(c) 2019 National Homeland Security Conference Presentations (Discussion)

For the upcoming 2019 National Homeland Security Conference, which will be held in Phoenix, AZ (June 17-20), the Management Team submitted three panel presentations highlighting regional, collaborative, and whole community preparedness efforts of the Bay Area UASI.

These presentations include the following:

- 1. <u>2018 THIRA and SPR Methodology: A Local Approach to the Federal Mandate.</u> A panel will discuss the approach taken by three jurisdictions from across the country in response to changes to the THIRA/SPR. Panel members include: Amy Ramirez, Regional Project Manager, Bay Area UASI; a representative from Denver, Colorado, and a representative from Tampa, Florida.
- Strategies Against Targeted Violence. A panel will discuss community efforts to address all forms of targeted violence. Panel members include: Mikyung Kim-Molina, Regional Project Manager, BA UASI; Brett Steele, Regional Director of Strategic Engagement, DHS; and Junaid Afeef, Director, Targeted Violence Prevention Program, Illinois Criminal Justice Information Authority.

- 3. <u>Mitigating Risks During Catastrophic Wildfires</u>. A panel of SMEs will discuss the challenges of handling multiple catastrophic events requiring public information and warning, mutual aid, and coordination across jurisdictional authorities.

Discussion:

Background

The FY19 UASI Project Proposal Guidance stated that the Bay Area UASI Management Team will report all "Level One" and "Level Two" regional proposal submissions to the Approval Authority, along with funding recommendations based on the region's risk and gaps as well as funding availability.

Level One projects are: training and exercise, fusion center, public safety information sharing, BayRICS/interoperability, public health and medical, and projects implemented by the Management Team (see Table 1, page 3). These projects are presented directly to the Approval Authority.

Level Two projects were first vetted by a Bay Area UASI regional work group prior to the October 12, 2018 proposal submission deadline. These projects, including the recommended allocations listed here (see Table 2, page 4), will be reviewed in Agenda Item 11.

Analysis

"Level one" proposers will present their projects listed in Table 1, annual reports, and request approval for the requested FY 2019 amount (agenda items 6-9).

"Level two" regional projects listed in Table 2 will be summarized by Regional Program Manager Janell Myhre (agenda item #11) and project leads will be available to answer questions.

Please note that the Management Team's current funding recommendations for the regional projects assumes that our FY19 grant will be the same as last year, the State will retain the same percentage of the grant as last year (i.e. 17.5%).

The Management Team will provide final funding recommendations once DHS announces the FY19 grant award amount, likely at either the May or July Approval Authority meeting. At that time, the Approval Authority will also review/approve all hub projects recommended by hub voting members.




Total Courses Offered (2011 – 2018)

Total Students Trained (2011 – 2018)



Courses by Discipline (2016-2018)



Students Trained by Discipline (2016-2018)



The Northern California Regional Intelligence Center is the State designated and federally recognized fusion center for the region. As a multi-jurisdictionally staffed center with many subunits and disciplines, the fusion center is dedicated to the mission of information sharing and providing analytical support to both public safety and private sector critical infrastructure partners within the UASI Area and the Northern Federal District of California. The following information is being provided to give an overview of the fusion center's activities from January 1 to December 31, 2018.

UASI FUNDED PROGRAMS:

TERRORISM LIAISON OFFICER OUTREACH PROGRAM - (TLOOP)

<u>Duties:</u> Provide outreach and training to regional partners; review all submitted Suspicious Activities Reports (SAR); follow up on SARs and threats to public safety that require additional information collections and dissemination.



INFORMATION TECHNOLOGY—CYBER

Personnel assigned: Four (4)


<u>Duties:</u> Cyber team members provide cyber support to local agencies to increase cyber awareness and assistance in the event of a cyber event. NCRIC Cyber Team members currently sit on eight (8) Cyber-related Boards and Committees.

<u>Activities:</u> The Cyber Team saw an increase in cyber reporting, support, and regional presentations between 2017 and 2018. The team also participated both nationally and internationally to provide and disseminate information on supply chain and water supply.



DIGITAL FORENSIC EVIDENCE LABORATORY

The NCRIC continues to support the Digital Forensic Evidence Lab (DFEL), which reviews data stored on computers and other portable electronic devices. This work assists in efforts to arrest and convict those engaging in criminal acts.




RISK MANAGEMENT UNIT (RMU)

The RMU is the NCRIC lead for Vulnerability Assessments, Threat Assessments, Special/Large scale Event Support, and the National Special Events Data Call. The NCRIC provides support for events based on the potential risk of criminal activity and provides real-time information sharing and analytical support.

Personnel assigned: Three (3)

<u>Duties:</u> Conduct Special Event Threat Assessments (SETA), along with providing on-site analytical support at Federal SEAR-level special events. Conduct Sector Snapshots for threat and vulnerability awareness at locations that contain Critical Infrastructure.

<u>Activities:</u> In addition to conducting assessments, the team participated in the development and issuance of six (6) Critical Infrastructure Awareness Bulletins (CIAB) to all NCRIC partners and made a presentation at the 2018 National Homeland Security Conference in New York.




PRIVATE SECTOR OUTREACH

Personnel assigned: Two (2)

<u>Duties:</u> Develop/facilitate participation by owners and operators to protect critical infrastructure; provide vetted members with highly valued, sensitive information and intelligence; enhance private sector engagement capabilities.

<u>Activities:</u> During 2018, the team participated in the development and deployment of the Global Mission Assurance Portal (GMAP) to provide fusion centers with Department of Defense supported technology and the Center of Best Practices, an element of the Homeland Security Information Network - HSIN Intelligence Community of Interest (COI).




ANALYTICAL SUPPORT (NCRIC- AMT, VAT, Priority Crimes, CSU)

Personnel assigned: Nineteen (19)

<u>Duties:</u> Various- Analyze both transnational and domestic terrorist organizations; provide analytical support for requests for information, analyze Suspicious Activity Reports (SAR); Analyze regional criminal activity; coordinate intelligence sharing, provide investigative support, and manage the Gun-Related Intelligence Program in Santa Clara County.

<u>Activities:</u> 2018 saw an increase in Suspicious Activity Reports (SARs) which were analyzed for deconfliction and determination of a criminal and/or a terrorist nexus. Partner update briefs for regional crime trends and national threat reporting also increased. Information, background package, and case support requests from local law enforcement agencies decreased during 2018.



TRAINING FOR CALENDAR YEAR 2018


In 2018, the fusion center increased the number of training classes conducted from 63 to 107. These classes related to homeland security, narcotics enforcement, law enforcement officer safety and investigative techniques. Approximately 1,400 students from allied agencies and organizations attended.

PILOT PROJECTS

The NCRIC/NCHIDTA participated in and/or chaired several national and local pilot projects in 2018, including:

- **FBI Enhanced Engagement Strategy.** This two-year project is a joint collaboration between the FBI, DHS, ODNI Partner Engagement-Information Sharing Environment (PE-ISE), and fusion centers. Chaired by a NCRIC member, the project focuses on enhancing analytics and counterterrorism threat identification, prevention, mitigation and investigation. The FBI has adopted this Strategy to develop a path for enhanced collaboration and capabilities between fusion centers and the FBI.
- Fusion Center Privacy Policy Update. This joint FBI, DHS, PE-ISE, US DOJ collaborative project focuses on updating Privacy Policy templates for all 79 national Fusion Centers. A NCRIC member represented the NFCA on this project which is set to be completed in early 2019. The NCRIC leads national efforts to implement this national guidance.

• Social Media Partnerships. The NCRIC continues to partner with various Social Media companies (Google, Facebook, Twitter, etc.) to provide information to Public Safety agencies when a Threat-to-Life is seen on social media. Potential online threats frequently have not been reported to authorities through existing platforms. This NCRIC-led effort is working to improve credible threat identification and coordination in life threatening situations.

The Management Team has completed its planning for the 2019 risk management cycle in partnership with jurisdictions, the NCRIC, and Haystax Technology. Please see Appendix B for the outline of the Risk Management Program schedule for CY 2019.

Risk Management 2019 Program Highlights

- The UASI Management Team will hold a Risk Management kick-off webinar for stakeholders.
- Haystax will release an upgraded version of Cal COP, which provides an improved user interface and requires less training than the previous version.
- Jurisdictions will conduct their annual asset review to fill information gaps.
- The NCRIC will update the Aviation Sector in Cal COP.
- The UASI Management Team will review Cal COP user accounts for proper access levels.

THIRA / SPR 2019 Highlights

The UASI Management Team will:

- Hold a THIRA / SPR workshop in April to gather data for the Core Capabilities in the Mission Areas of Prevention, Protection, and Mitigation.
- Review the draft THIRA / SPR with the UASI Regional Workgroups in July and August.
- Present the completed THIRA and SPR at the November Approval Authority in preparation for submission to DHS/FEMA by December 31st.

Background:

Approval Authority Bylaws specify that the Approval Authority must use a risk and capability-based methodology to apply for and allocate grant funds. This is consistent with guidance from DHS that states that all levels of government must establish a foundation to justify and guide preparedness activities and investments. In addition, DHS requires all grantees to produce a Threat Hazard Identifications and Risk Assessment (THIRA) and a Stakeholder Preparedness Review (SPR) on an annual basis.



Bay Area UASI Risk Management Program

January 2019

Each year the Bay Area UASI Risk Management Program includes data input, validation, assessments, and reporting to support decision-making and guide grant spending. A risk and capability-based methodology to allocate UASI funds is required by the Department of Homeland Security and is mandated in the Bay Area UASI Approval Authority Bylaws.

This year, there are three steps to our risk management process:

1. Risk Management Kick-Off Meeting

WHO: All Bay Area UASI regional and subject matter experts involved in risk management

WHAT: The Bay Area UASI Management Team provides an overview of the risk management process for the grant year, the new requirements for the Threat and Hazard Identification and Risk Assessment (THIRA) and Stakeholder Preparedness Review (SPR); the California Common Operating Picture (Cal COP) for Threat Awareness; as well as Protected Critical Infrastructure Information (PCII) certification requirements.

WHEN: February 14, 2019, 10:00 am – 11:00 am

WHERE: WebEx with the option to attend in person at the Bay Area UASI Office, 711 Van Ness Ave, Ste. 420, San Francisco, CA 94102

2. Asset Updates and Validation

WHO: OA and NCIRC subject matter experts who are PCII trained and certified Cal COP

users.

submits it to the PCII office for certification as needed.
